### Permission for Action:

It is understood that caution will be taken by the camp director and staff to prevent injury; however, injury sometimes occurs during camp. In the event of an accident none of the following shall be held responsible: Executive Director, nurse, counselors, staff and Summit Grove. In the event of an emergency where medical treatment is required, I give permission to the physician selected by the designated camp staff to hospitalize, secure treatment, to order injection, anesthesia or surgery for the camper. Please notify me in case of such an emergency. Any claim or dispute arising from or related to this agreement shall be settled by biblically based mediation and if necessary legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation a division of Peacemaker Ministries.
