



PARENT AGREEMENT 2021

SUMMIT GROVE'S SPECIALTY SUMMER CAMPS

I/we hereby enroll our child(ren) in a specialty summer camp at Summit Grove with the following understanding:

PROGRAM GOAL

Summit Grove partners with parents/guardians and the community in providing a unique summertime experience that will provide life-long benefits for each child.

CAMP STAFF

Camp staff abide by the beliefs and standards of conduct as set forth in the Summit Grove Mission Statement & Core Values. Camp leaders are chosen based on their quality of character and desire to be leaders and mentors to children. All staff that have direct contact with campers will submit the appropriate clearances.

CHAPEL & DEVOTIONS

Campers will attend chapel daily for a time of singing and learning from the Bible with all campers and may meet for time of Bible-based devotions in small groups.

SUMMER CAMP RULES

Three rules sum up behavior expectations – obey leaders/staff, be kind to others, be nice to things. These rules, as well as other specific expectations, will be clearly communicated to the campers.

DISCIPLINE

The Program Director, camp leader and staff make and enforce camp regulations in a manner consistent with Christian principles (not to include corporal punishment). Reasonable restraint may be used when providing for immediate safety. SG reserves the right to dismiss any child who does not cooperate with the program's rules of conduct. Tuition will not be refunded for the days in which a student is dismissed.

DRESS CODE/SWIMMING ATTIRE

Campers are encouraged to wear comfortable clothing and shoes for outdoor play, as well as any appropriate items for the specialty camp. Girls need one piece or tankini-style swimsuits to adhere to the camp's modesty policy. All campers should bring a water bottle, swimsuit, towel, flip flops, and sunscreen in a small bag each day.

ILLNESS

If your child experiences any of the following conditions, they should be kept at home until they have been symptom-free **24 hours** or are cleared by a physician: fever greater than 100 degrees Fahrenheit, upper respiratory tract infection, vomiting, diarrhea, conjunctivitis (pink eye), streptococcal pharyngitis (strep throat), chicken pox, lice or scabies, impetigo or fungal skin infections.

REGISTRATION AND TUITION

To register, parents/guardians need to submit a completed registration form (including emergency information) and fee per camper. All notices and statements will be emailed to the primary billing contact indicated on the registration form. No refunds will be given for missed days.

CHANGES TO REGISTRATION FORM

Changes are to be submitted to the Summit Grove Program Director two weeks before the change is to occur. Any changes to the registration form must be approved by the office. After two changes, a \$15 processing fee will be added for each additional change.

LUNCH & SNACKS

Lunch and two snacks are included in the price of tuition. A weekly menu will be provided shortly before the start of the camp.
